Scholarship Essay Topic and Requirements

Pelham Fish and Game, Inc. is a family-oriented club that promotes education, conservation, sportsmanship, and safe and responsible firearm use. We're looking for decidedly pro-Second Amendment essays only.

Essay Topic - The Second Amendment

During the 18th century, the Bill of Rights was adopted as part of the Constitution of the United States. The Constitution includes the right to bear arms (the Second Amendment). The Second Amendment has become a fundamental right since its adoption over 230 years ago. With the recent series of tragic events and the extensive coverage by the media, there are people and elected officials calling for increased restrictions on the Second Amendment.

Discuss why Second Amendment continues to be an integral part of the Constitution.

Your essay must address one or more of the following questions:

- *What were the circumstances surrounding the inclusion of this amendment and how is this shown through the introductory statement?*
- *What was the intention of the framers in placing this as the second enumerated (numbered) right of the People?*
- *What is the importance of the Second Amendment in relation to other amendments?*
- *How does the Second Amendment play a vital role in protecting our freedoms today?*
- *What has changed so dramatically for some to call for the repeal of the Second Amendment?*

Minimum requirements:

- ✓ Your essay must discuss the specified essay topic and must address at least one or more of the stated questions.
- ✓ Your essay may not exceed 2000 words and must be typed and double spaced.
- ✓ You must utilize at least three references and cite all sources used using MLA format.
- ✓ You may include quotes from your sources/references, but the majority of the essay must use YOUR words, thoughts and ideas.

Be sure that you meet the Scholarship criteria (outlined on page 1) and submit the following:

- completed Scholarship application
- a brief letter of introduction
- your essay
